12. Proposed 2013-2014 Budget (Brad Braley) – President Braley reviewed his Club and Foundation Budgets for the year.

Mare moved to accept the amended budget, Alexa 2<sup>nd</sup>. The motion was approved.

13. Foreign Exchange Sponsor Opportunity (up to \$600)

Joe Gitta reported that he was not able to recruit enough members to host an incoming Youth Exchange student this year.. Kimberly Buros, District Youth Exchange Chair, found a family in Dubuque to host, but Dubuque is already sponsoring two students and but needs funds now to help them out for up to half the year.

Moved by Gary W. 2<sup>nd</sup> by Chad F. – motion carried to approve paying half of the student stipend.

## 14. Funding requests

Brad shared information received from Lynn Barnes, CF Kiwanis Rough Risers regarding having signs at the entrances to Cedar Falls with the service clubs listed. The board was supportive of the idea. Brad will communicate this to Lynn and will bring a firmer proposal when there is one.

- 15. Club Project(s) updates & nomination(s)
  - a. Octoberfest will be September 20-21. Leslie needs a copy of the Insurance coverage. Gary W mentioned he might have more information on it.
- 16. Cedar Falls Rotary Club Foundation Recognition Points (from Mike Butler) We have approximately 2 dozen members who, who in total have accumulated over 15,000 Foundation Recognition Points (FRPs). In order to foster greater giving to RI Foundation we recommend the following:

A point for dollar match will be made for any member contributing to their first Paul Harris Fellowship. There is a \$100.00 minimum and the contribution must be made between July 1, 2013 and June 30, 2014. This point match will not exceed the credit required for their first PHF.

The match is only against dollars the member is contributing. It is intended to increase giving so may be included with other club recognized programs.

Scott moved and Mare 2<sup>nd</sup> – Steve inquired if PH points could be earned through service hours. Pres. Braley will inquire of Mike. Motion carried.

17. Membership and Retention Committee update (Chad Feldmann)
They are looking into providing reduced membership for new members under a certain age for a couple of years. Their Committee wanted more information.

They are working on developing a membership survey. – moved by Mare, 2<sup>nd</sup> Alexa. Moved.

They suggested providing copies of the Rotarian to guests & potential members and the Public Library. Cooley moved we order 5 extra copies to hand out to prospects/mo. and an extra copy for the CF Public Library. Motion carried. In response to a question of who is responsible for doing this, it was mentioned that Erv usually handles ordering things like this.

- 18. Website Committee update (Chad Feldmann) Looking into more information on managing the Club Runner program. Chad currently doubts we have the manpower to implement the new program.
- 19. There was some discussion about having gifts for Rotary speakers. Brad will check with Erv on what inventory of gifts we have on hand and see what we might need.
- 20. Gary W. mentioned John Larsen's resignation from the club due to conflicts last year, and raised the possibility of John qualifying for the Rule of 85, so he could resume membership. The board was very receptive of trying to re-engage with John. Gary W. will approach him.
